### 3. Purpose of data processing

The purpose of the processing is the organization of the course. For the registration the software Indico<sup>1</sup> hosted by DKRZ will be used.

Fields marked with an \* are mandatory fields that are required for the registration process. If you do not provide these details, you cannot take part in the course. The legal basis for processing is Article 6, para. 1, lit b GDPR. Fields not marked with an \* are fields which you can complete voluntarily. By completing the voluntary fields, you give us your permission to store and process this data exclusively for the registration purpose.

The questions and answers will be collected in an editable document (hedgedoc) hosted at GWDG<sup>2</sup>, or Google<sup>3</sup> doc, and later on it will be anonymised part of DKRZ's documentation.

### 4. Legal basis of data processing

The legal basis of data processing for event organization is the contract that is concluded with us upon registration (Art. 6 Abs. 1 lit. b GDPR). If you have consented to this, the legal basis for the collection of participant statistics is precisely this consent (Art. 6 Abs. 1 lit. a GDPR). The legal basis for processing in these instances is Article 6, para. 1, lit. f GDPR (legitimate interests of the controller).

### 5. Data recipients and categories of data recipients

The registration data are collected and used within DKRZ for the sole purpose of organizing and realizing the DKRZ Python Course for Geoscientists, which will be held as a virtual event. The course will be held using the videoconference software Zoom<sup>4</sup> hosted by UniHH. The course material will be made publicly available on the DKRZ Indico<sup>1</sup> website.

A passing on of data to third parties does not take place.

### 6. Storage duration

The data collected during the registration process will be stored until no later than one year after the respective course.

### 7. Your rights

You are entitled to the rights of access (Article 15 GDPR), rectification (Article 16 GDPR), erasure (Article 17, para. 1 GDPR), restriction of processing (Article 18 GDPR), data portability (Article 20 GDPR) and withdrawal of consent (Article 7, para. 3 GDPR).
